

## **Competition Terms and Conditions – Tom’s Kitchen competition**

By participating in this competition, entrants agree to the following Terms and Conditions:

1. **Promoter:** VenuesLive Management Services Pty Ltd, operator of Tom’s Kitchen, Montague Road West End.
2. **Eligibility:**
  - Employees of Queensland Ballet, VenuesLive Management Services Pty Ltd, Shane D Pty Ltd, Shane Delia, and each of their immediate family members are not eligible to enter.
3. **Entry Requirements:**
  - Entry to the competition is free.
  - To enter, participants must scan the QR code (available at locations throughout the Tom’s Kitchen) that will take participants to the Tom’s Kitchen website, for the participants to complete the on-line survey form with their personal information (first name, last name, date of birth, email address and mobile number). Failure to complete the online form in full will result in the entry being invalid and ineligible.
  - Only one entry per person is allowed.
4. **Competition Period:**
  - The competition begins on 11 May at 7am and ends on Sunday 8 June 2026 at 2:00 pm.
  - Entries received outside this period will not be considered.
5. **Prize:**
  - The prize is a voucher valued at \$100 to Layla restaurant at Thomas Dixon Centre, Montague Road West End.
  - The voucher will be delivered to the winner within one (1) month of the Competition closing date.
  - The voucher is valid for six (6) months from the date of issue and must be redeemed within this period, unless extended by the Promoter. To redeem the voucher the winner must book directly with the Promoter.
  - If the winner does not redeem the voucher within the six (6) month validity the Promoter may extend the validity period, but they are not required to do so where all reasonable efforts have been made to accommodate availability, and the voucher is deemed forfeited and no alternative prize or credit will be offered.

- The voucher is not transferrable, and cannot be exchanged or redeemed for cash in part or in full.
- The winner must not use the voucher in conjunction with any promotional activity of the winner.

#### **6. Selection of Winner:**

- The winner will be selected randomly from all eligible entries after the Competition Period ends.
- The winner will be notified by email or phone, via the contact details provided in the on-line form within 7 days of the Competition closing date.

#### **7. Claiming the Prize:**

- The winner must confirm acceptance of the Prize within 48 hours of being notified.
- If the winner cannot be contacted (i.e an email notification is returned as undeliverable; a phone is disconnected), the winner does not respond within this timeframe to claim the Prize, or the winner cannot verify their age, a new winner may be selected from the remaining eligible entries.

#### **8. Data Collection**

- The Promoter collects personal information for the purposes of processing and administering entries to the Competition, and the provision of the Prize.
- The Promoter may disclose entrants' personal information to third parties to assist in conducting the Competition and providing the Prize.
